Warrior Women Challenge Terms and Conditions

- 1. This is a women only event for those 18 years and older; however, children of either gender can participate (accompanied by a woman participant).
- 2. All participants must be registered before taking part. Registration must be completed online.
- 3. Entrants who will walk the event must be registered online.
- Registration costs £15 for ages 18 and over and £10 for ages 17 and under. Your registration fee covers the event's costs, including your medal, t-shirt and insurance.
- 5. I understand that my registration fee is not refundable.
- 6. Sponsorship is essential in order to raise funds for Trevi.
- 7. All entries will be processed in the order we receive them.
- 8. Closing date for registrations will be Monday 3 October or when all places have been sold, whichever is the earliest. Note that places are limited.
- 9. Early registration is recommended to avoid disappointment.
- 10. If, for whatever reason, the event cannot take place, we will offer a virtual option, and all participants will be encouraged to take part.
- 11. We reserve the right to cancel the event due to any Covid-19 related restrictions or concerns.
- 12. You are not permitted to 'give' your place to anyone else.
- 13. If you are unable to take part nearer the time, please contact Trevi on 01752 255758 or email fundraising@trevi.org.uk. Your place will then be put on a waiting list for other interested parties to take part.
- 14. Upon registering for the event, you will be emailed your event pack, which will include directions and instructions for the day, a link to set up your online registration form and / or download a paper-based sponsorship form.
- 15. Your pack will arrive by post a week before the event. Your Warrior Woman tee can be collected at the start of the event, please make sure you have indicated your size on registration! We would love you to wear your tee with pride.

- 16. We would love you to raise as much as possible to support Trevi every pound you raise will help go towards women affected by trauma and abuse. Your support will help them achieve a vital fresh start in life.
- 17. You are not permitted to raise any sponsorship you raise to pay any of your expenses. All sponsorship money collected by you must be passed directly to Trevi.
- 18. This event is a fun event built on courage and connection. We want everyone to have a great time, but we ask you to behave in a respectable manner, considering other participants and members of the public who may also be out enjoying the countryside and abiding by the countryside code for example, don't forget to close those gates!
- 19. By taking part in our event, you implicitly authorise the future use of your image (photograph or video) for publicity purposes.
- 20. We reserve the right to change the fees, event details, prizes, and any aspect of event management organisation.
- 21. Water will be supplied at the event; however, we encourage all participants to bring their own food and refreshments.
- 22. Parental Consent: all participants aged 16 and under must always be accompanied by a female parent or guardian who has also registered for the walk.
- 23. I understand that I should be of reasonable health and fitness to undertake this walk.
- 24. I understand that some parts of the course may be unsuitable for participants with disabilities, health issues and/or medical conditions and that I should contact the Trevi Team if I have any needs which must be considered.
- 25. I understand that I MUST provide emergency contact details of someone not taking part in the event to confirm my place.
